# REQUEST FOR PROPOSAL

Long-term, viable and sustainable management models to help ensure Fox Creek Bike Park can be maintained, and enhanced, as a premier mountain bike destination.



## PERAMANGK AND KAURNA COUNTRY

Fox Creek Bike Park is situated on shared Peramangk and Kurna country. The Peramangk and Kurna People cared for the Land and the natural environment through lore and customs for more than 50,000 years.

The Country was well endowed with resources, food, water, firewood, and raw materials such as stone; timber and resins for tool manufacture; bark for huts, shields and canoes; pigments for painting; and furred animals for warm rugs. During winter, warm, dry huts of branches, bark grass and leaves, were constructed, often built around the hollow side of old red gums. Cudlee Creek runs through the bike park near the lower car park and is known by the Peramangk as Kadli-parri. This translates as Dingo Creek, named after the wild dogs which once lived here in abundance.



## INTRODUCTION

Fox Creek Bike Park has been a favourite mountain biking destination for decades. Spanning across over 50km of single track and 75km of fire track trails, the park has significantly contributed to recreational tourism in the Adelaide Hills.

The landowner, ForestrySA, is a statutory corporation responsible for managing public plantation forests for commercial production, native vegetation for conservation and cultural heritage. It operates in accordance with best practice standards for forestry operations and sustainable environmental management.

Following the 2019 Cudlee Creek Bushfire, the park underwent a comprehensive rebuild, supported by significant bushfire recovery funding and countless volunteer hours. The park remains popular with an estimated 120,000 visitors in 2023-24 and is free to the public to use.

ForestrySA is committed to identifying a viable management model to ensure Fox Creek Bike Park can continue to be a premier, nationally respected, mountain bike destination; alongside ForestrySA's core operations.

The future of Fox Creek Bike Park hinges on sustainable management to maintain its contribution to tourism, the economy, and community well-being. Your ideas, proposals, and feedback are crucial to developing a sustainable management model that will keep our park thriving.

## BACKGROUND

Fox Creek Bike Park, located in Cudlee Creek, South Australia, has been a beloved mountain biking destination since the early 1990s.

The park is spread across more than 800 hectares, featuring a jumps park, skills area, 50km+ of downhill, gravity, cross country and all terrain single track trails, multiple kilometres of gravel tracks and 180 metres of vertical elevation, and is open to riders of all ages and skill levels. Managed by ForestrySA, Fox Creek Bike Park, has played a pivotal role in promoting outdoor recreation and tourism in the Adelaide Hills, drawing community, social and competitive riders alike.

In December 2019, Fox Creek Bike Park was devastated by the Cudlee Creek bushfire, which severely impacted the trails and infrastructure. Following this destruction, a major effort was undertaken to rebuild the park with a vision to make it bigger and better. This reconstruction has not only restored the park's status as a premier mountain biking destination but also helped reinvigorate the local economy and community as they recovered from the disaster.

A notable addition in the redevelopment has been the introduction of adaptive mountain biking trails, making Fox Creek Bike Park more inclusive for riders with disability. This dedication to building adaptive trails reflects the park's commitment to accessibility and creating a more welcoming environment for all riders.

## OBJECTIVE

Fox Creek Bike Park has made an impressive recovery and is now back in operation with significant upgrades to trails, infrastructure and public amenities. ForestrySA faces ongoing challenges in maintaining the high standards required for such a popular and growing mountain bike destination.

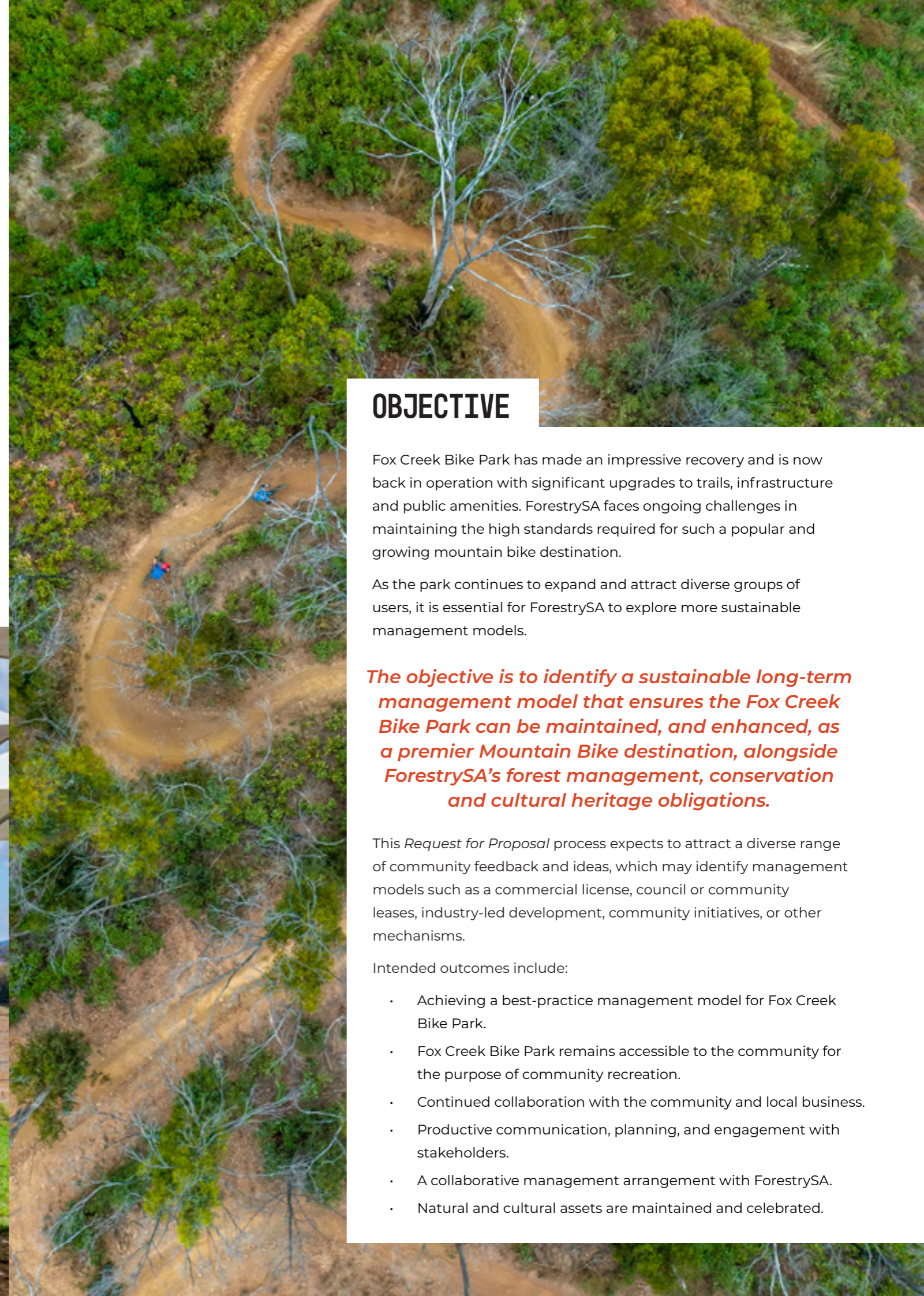
As the park continues to expand and attract diverse groups of users, it is essential for ForestrySA to explore more sustainable management models.

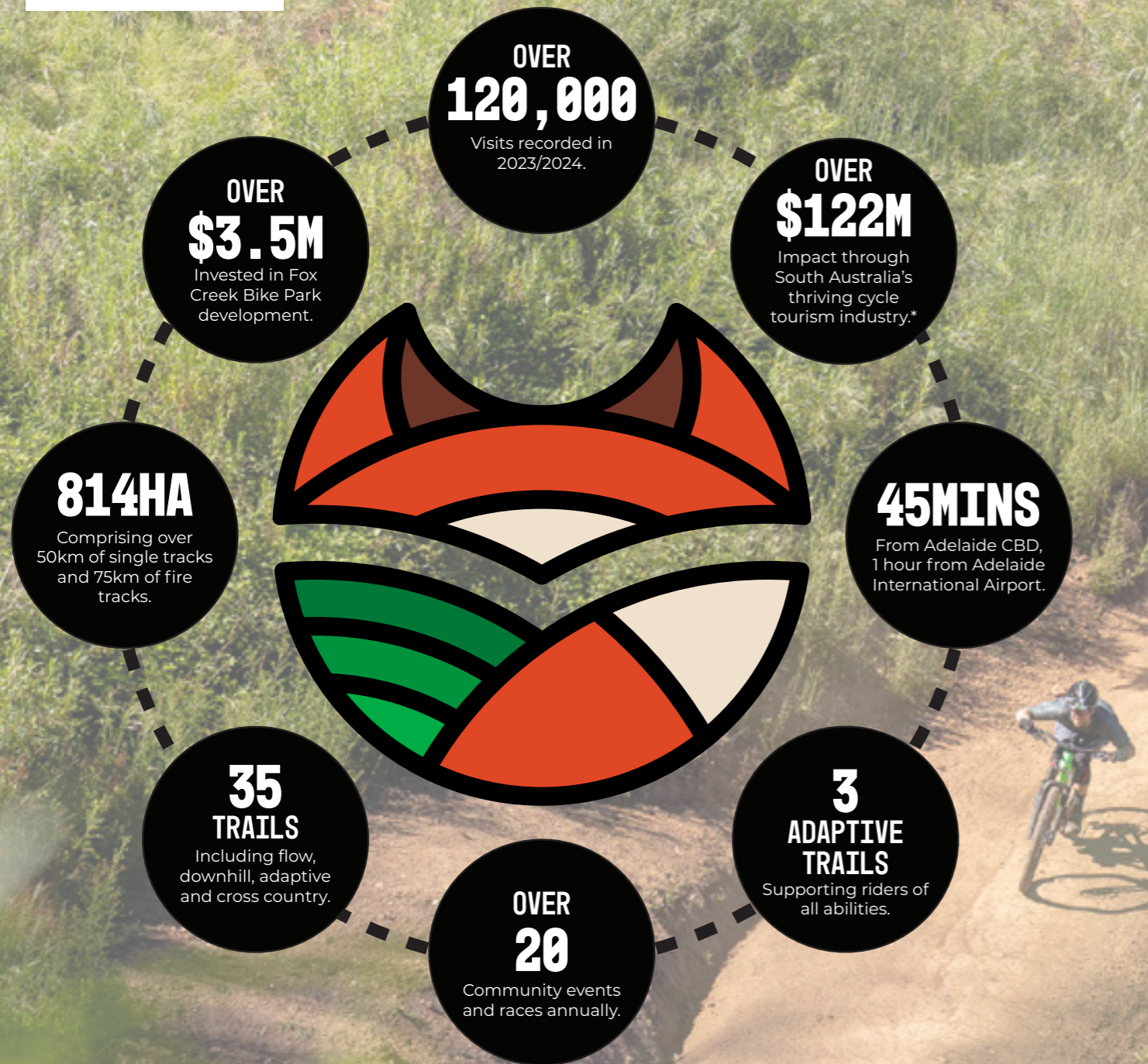

- Fox Creek Bike Park remains accessible to the community for the purpose of community recreation.
- Continued collaboration with the community and local business.
- Productive communication, planning, and engagement with stakeholders.
- A collaborative management arrangement with ForestrySA.
- Natural and cultural assets are maintained and celebrated.

## PROCESS

### STAGE 1 | NOVEMBER 2024 – JANUARY 2025

Request for Proposal submission process commences, including:

- Stage 1 will close at **5pm, Friday 31 January 2025**.

### STAGE 2 | FEBRUARY 2024 – MARCH 2025

- Panel consideration of proposals, alongside community feedback from YourSay.
- Site visits and presentations from shortlisted proponents (if required).

### STAGE 3 | APRIL 2025 – JUNE 2025

- Detailed financial assessments and direct negotiation with shortlisted proponents (if required).

5. Meet all costs associated with preparing a proposal and participating in the process, unless agreed in writing.

1. This document is provided to assist proponents in making their own appraisal of the opportunity presented, and in deciding whether to submit a proposal. ## EVALUATION OF PROPOSALS

- ForestrySA will establish a panel to carefully consider how each proposal meets the assessment criteria.
- Alongside the Request for Proposal, ForestrySA will be operating a YourSAy consultation platform for the community to provide feedback on their expectations and needs in regard to future management of Fox Creek Bike Park.
- Feedback from yourSAy will be presented to the panel for consideration and discussion alongside the proposal.
- Proponent's may be invited to meet with the panel to further discuss their proposal and its viability.
- The panel will determine which proposals, if any, will proceed to stage 3 (direct negotiation).

## FORESTRYSA RESERVES THE RIGHT TO:

1. Choose information that is to be disclosed. Nothing in this process obliges the disclosure of any information to the proponent or its subcontractors, representatives or external advisers.
2. Extend the closing date.
3. Amend the requirements at any time prior to the closing date.
4. Seek additional information from one or more of the proponents on any issue at any time and to continue discussions with one or more of the proponents.
5. Discontinue discussions at any time with any proponent.
6. Enter into discussions with any other person or company who is not a proponent.
7. Allow a proponent to change a proposal.
8. Withdraw opportunities from this process before or after the receipt of proposals.
9. Seek the advice of external consultants to assist in the evaluation or review of proposals.
10. Make enquiries of any person, company or organisation to ascertain information regarding the proponent and the proposal.
11. Consider an incomplete proposal.
